Karla thanks everyone in attendance and a round robin of introductions was done.

Raul provided the group with a copy and an overview of the meeting minutes from February's Task Force meeting.

Action Plan Implementation

Karla provided the group with a brief overview of the agenda.

The Task Force broke up into two groups based off the information that was identified at last month's meeting:

- 1. Safe Mediations Disposal
- 2. Marketing, Education, Presentations and Outreach

Each group held a discussion to identify several activities in the action plan they would like to begin implementing.

Report Out

Each group reported out to the larger Task Force.

The Safe Medications Disposal group plans to work on increasing:

- The number of Rx drop-boxes there is funding available through the Governor's Office;
- Community awareness of drobox locations;
- Awareness among older adults about unintentional Rx poisoning;
- The number of drug take-back events; and
- Community knowledge of safe storage options and best disposal practices.

The activities the Safe Medications Disposal group will implement first include:

- Advertising Rx Drop Box locations on community partner's websites including Banner-UMC, the Health Department, Healthy Pima and the Pima County Public Library.
- Conducting public service announcements on radio stations and TV networks, including KGUY in Green Valley (PCHD) and 30-second sports on TV networks (PCOA).

The Marketing, Education, Presentations and Outreach group would like to target high schools, possibly middle schools, and colleges. They would like to conduct health fairs at college campuses and increase the number of youth coalitions, possibility establishing new ones where needed. The group would like to increase the number of Rx360 trainers both within the group and among parents and caregivers. The group considered offering a no-cost Rx360 toolkit training. Additionally, the group would like to partner more with Parent Teacher Associations (PTAs) to increase the number of events and community forums and provide them at locations that are easier to access, such as the YMCA.
